NEW BUSINESS:

AUTHORIZE: No Parking on Main Street for Homecoming Parade

APPROVE: Variance Request for 344 E Main St

The Planning Commission held a Public Hearing on Monday, August 24, 2015 to consider a variance request from The Foundation House under Section 19-63 Residential Districts of the City Code for a ladies substance abuse recovery house.

During the hearing there was one objection to the request in-person and one written objection that were received. After hearing more details on the rules and operations of the house from the Ladies from the Foundation House, the neighbor who initially objected withdrew his objection. The Planning Commission considered the materials submitted with the request and voted to recommend granting the variance. The request is being submitted to the City Council acting as the Zoning Board of Appeals. A copy of the Variance Request is attached.

The relevant section of the Ordinance states that the intent of the Residential district is "To prohibit business, commercial or industrial use of the land, and to prohibit any other use which would substantially interfere with development or continuation of single-family dwellings in the district."

APPROVE: Variance Request for 112 S. Church St.

The Planning Commission held a Public Hearing on Monday, August 24, 2015 to consider a variance request from Clare and Norma Ransom under Section 19-63 Residential Districts of the City Code to waive the prohibition against first-floor residence within the downtown commercial district for their commercial property at 112 S. Church St.

The City received several written and verbal objections to granting this variance. The Planning Commission voted to recommend not to grant the variance. The request is being submitted to the City Council acting as the Zoning Board of Appeals. A copy of the Variance Request is attached.

The Ordinance which the variance would waive, 388.10, became effective in May of 2010, and states in part: "Dwelling units shall not be located below the second floor" of the district within which the property in question is located.

CITY MANAGER'S REPORT:

The sewer line crossing the Bean Creek appears to have been damaged by the Willow tree which fell over due to the very heavy rain in late June. The flow rate increased to over 800,000 gallons per day, and then over 1,000,000 gallons a day. This greatly exceeded plant capacity, and was in danger of causing the destruction of the microbes at the WWTP, as well as excessive consumption of chemicals and electricity. The DEQ was properly notified, and they directed that we proceed with a bypass of the suspected rupture until repairs could be completed. City staff and Fleis & VandenBrink were assisted by Mr. Chris Gazlay of Grady Sand & Gravel in locating a good company (MacAllister Underground Shoring and Pump) to install the bypass, which was activated on August 14th. The flow rate immediately decreased to 420,000 gallons, and has remained at this level since. The WWTP continues to recover, and is operating within proper parameters. Fleis & VandenBrink continues to coordinate with contractors to prepare a proposal to conduct the trunks. Fleis & VandenBrink has submitted permit requested to the DEQ. Repairs are not likely to be completed until early October, and the bypass will remain in place until then. The City has submitted this as an insurance claim, but we have not yet determined whether the claim will be covered.

- The Engle Trail dedication ceremony is scheduled for Wednesday, September 2nd at 11:00 a.m. The location is at the northwest corner of M-34 and Munson Highway. This ceremony is open to the public.
- The Local Bridge Improvement Project for the Jackson and Mechanic Street bridges is projected to be scheduled for a December bid-letting by MDOT. This schedule will hopefully result in competitive pricing by prospective contractors, with work expected to occur during the May-June 2016 timeframe.
