CITY MANAGER'S REPORT:

- N. Maple Grove Phase 1 Construction: The project is complete. Final administrative items, such as bond surety and lien waivers are being finalized, along with determination of final quantities. We expect to receive the final pay application and adjusting change order in time for the December 1st Council meeting. Also on December 1st, City Manager, Steven Hartsel will ask Council to decide whether to proceed with the RDA loan program or with the Phase 2 pay-as-we-go approach to completion of the reconstruction.
- With the recent increase in local COVID cases, we are partially returning to the measures we used earlier this year to minimize city employee contact and spread of the virus. We are still able to maintain the same level of customer service.
- We have sent letters to our Seniors regarding the upcoming change to roll-out refuse carts, and asked them to decide which type of container (large or small) they prefer to receive when Modern Waste provides these in about two months.
- The new HPD Durango Police Vehicle is back in town after outfitting, and will be placed in service very soon, following the installation of a couple of final items.
- The General Election on November 3rd was well-executed by all election workers and City staff. This was a considerable accomplishment, considering the many rule and procedural changes throughout the year. Well done to all of the ladies who worked a very long day to conduct a fair, transparent and accurate vote. The County completed their canvassing late on November 12th.
- We received notification from the State Tax Commission that on October 20th, they voted to officially return the tax roll back to the City following the correction of all AMAR discrepancies and the completion of the reassessment.
- Even though there will be few Christmas parades this year, the DTE foundation is still awarding grants to local municipalities, including Hudson, through the United Way. We expect to use our grant toward additional downtown decorations and still have the Christmas Tree lighting ceremony on Friday, December 4th.
